



Crystal shared with Gloria that she was on the elevator in the abortion clinic to start the procedure to terminate the pregnancy by taking the RU-486 pill that would be administered to her. When she received a message on her phone from me saying that I was thinking and praying for her at that moment, she left the building! She realized that her baby was a blessing and she was going to keep it. It is amazing how a simple message of concern was able to open Crystal's heart to God's loving plan for her family.

I have talked with Crystal a few times since, and I still feel such a good connection with her. She is so happy. Crystal is now 21 weeks pregnant and expecting a little girl. The Life Center will help Crystal with baby needs, support, and my little phone messages.
