## GIVING THANKS FOR THE YES

It was Monday of Thanksgiving week when a young woman walked into our Women First Pregnancy Options center in Deer Park. We sat down together and talked so that I could listen to what her needs were to see how I could assist her.

Sonia\* was 21. She explained that she had just gotten married and wasn't ready to start a family. She thought she might be pregnant, and so I offered her a pregnancy test kit before moving forward. A few minutes later Sonia told me she read her test as positive. She repeated that she didn't want a baby yet and that she wasn't ready to be a mother. She also shared that she had taken the Morning After Pill and was very worried. Her fears included: what if the Morning After Pill doesn't work and the baby lives? If the baby is born, would the baby have abnormalities? Would she as a mother suffer any side effects?

I tried to reassure Sonia that God has a purpose for her and her new baby's life and that we were there to help. I expressed the importance of seeing her baby's ultrasound, something an abortion center would conceal from her. No fetal model I could show her, nothing I could tell her, would have the impact of seeing her own baby's heartbeat and movement while on the ultrasound screen. While Sonia was hesitant at first to see her ultrasound, she agreed to have me schedule a sonogram appointment and to see a doctor before she would make any decisions.

Sonia and her husband went to the sonogram appointment together with a lot of apprehensions. They didn't know much about parenting and felt overwhelmed and frightened. After seeing their first child on the screen, they met with the physician who informed them that their baby was about four months along and doing well. He was able to answer their questions and reassure them about continuing the pregnancy.

A few days later Sonia called and asked to come back to our office to talk. She and her husband visited us later that day, their faces beaming with joy. They were having a BOY!! They both hugged me and expressed their gratitude. It was our compassionate care, our educating them on the numerous resources and options available to them and their baby, as well as arranging the sonogram with a caring physician, which guided them to choose life!

Before they left our center, I familiarized them with what to expect throughout the pregnancy, encouraged breastfeeding, and offered some maternity clothes. I told them that we can help them take care of their son until he is two years of age by providing material aid such as a crib, car seat, and much more. I also reminded them, as we do all our clients, that we are only a phone call or visit away if they need any help!



## ***Our New Nemesis – Expansion of Chemical Abortions***

### **OUR 2022 RESULTS**

- Served **2,566** client visits
- Distributed **221** PTKs (Pregnancy test kits)
- Served **2,292** client visits with baby material aid
- Saved **42** babies lives!

**C**hemical abortions (aka the 2-day abortion pills/RU486) now represent over 65% of abortions vs. surgical abortions and provide greater profitability for abortionists due to ease of distribution (telehealth/mail order), enabling them to close brick and mortar locations and cut staff. Abortion centers cost to obtain the 2-day pills is \$80 vs. their turnaround charge to clients is up to \$800 depending upon gestational age of baby.

Recently, the Food & Drug Administration (FDA) quietly updated the rules for the two chemical abortion drugs mifepristone and misoprostol, allowing them widespread availability at retail neighborhood pharmacy chains such as **CVS, Walgreens, and now Rite Aid**. Now, with these dangerous drugs even more readily available, a vast number of women will be exposed to the dangers of at-home abortions. These abortions require neither a visit to the doctor nor a pregnancy test, and so in-store prescriptions and mail orders will essentially take the place of abortion providers.

A critical hazard of drugstore abortion pill sales is the purposeful elimination of possible life-affirming intervention by pregnancy care centers prior to a woman obtaining the chemical abortion. Bypassing a Planned Parenthood or abortion facility where a pregnancy care center is close by, removes the opportunity for a pregnant mom to see her baby's heartbeat on a sonogram, be educated on all resources available to her, explore adoption options, have a caring and compassionate advocate to help her through difficult situations i.e., coercion, rape, sex trafficking and much more. Women would not hear the truth they deserve to hear that might cause them to have a change of heart and reject abortion, sparing them a lifetime of agony. How is this women's health care?

**Did You Know...In 2000, when the FDA was considering approving the two chemical abortion drugs mifepristone and misoprostol, officials realized that the only way they could legally approve the drugs was by characterizing pregnancy as an "illness" and then argue that the drugs provided a "meaningful therapeutic benefit." They described pregnancy in the same category as cancer or pneumonia. That's exactly how the FDA approved the drug combo. We all know, pregnancy is not an "illness".**

**Doctors Hippocratic Oath to "do no harm"**— Doctors have for years warned the FDA of the dangers these drugs pose to their patients. The FDA has long ignored those warnings and failed to uphold its legal responsibility. **They:** • **Never** studied the safety of the chemical abortion drugs under the labeled conditions of use. They don't even know how safe the drugs are when women use them as directed. • **Ignored** the potential impacts of the hormone-blocking action the drugs have on the developing bodies of adolescent girls. • **Disregarded** the substantial evidence that chemical abortion drugs cause more complications than even surgical abortions. • **Eliminated** necessary safeguards for pregnant girls and women who undergo this dangerous drug regimen. Although the FDA and abortion activists claim the drugs are safe and effective, **they are not**.

Chemical abortions pose risk of severe side effects including hemorrhaging, the need for follow-up surgery, and even death. Multiple peer-reviewed studies such as those from the Charlotte Lozier Institute, found there is a 53% greater risk for an ER visit for chemical abortion complications 4x than that after a surgical abortion. Also, 34% of post-abortive women report an adverse change in themselves, including depression, anxiety, substance abuse, and thoughts of suicide.

Alliance Defending Freedom is now representing a host of doctors and medical organizations demanding the FDA to be held accountable for its failure to abide by the legal obligations to protect the health, safety, and welfare of girls and women, while also challenging the Biden administration and a key federal agency to defend the unborn and women from the dangers of chemical abortion drugs.
