Use your IRA for your gift – If you would like to make a gift now using your IRA and if you are at least 70 ½ years old and don't exceed your maximum of \$100,000.00 per year in qualified charitable distributions, you will not have to report your distribution as income. It will be free of federal and NYS income tax, and it will count toward your required minimum distribution (RMD). A spouse who qualifies can separately make up to the same \$100,000.00 annual contribution.

The best way is to start with your IRA Custodian. Tell them you want to make a "qualified charitable distribution." In most cases, you will only have to fill out a simple form. Very important – your gift must go directly from your IRA to the Life Center of Long Island. If you receive the distribution first, you will be taxed on the amount. You can make the Life Center of Long Island a beneficiary of your IRA and your loved ones will not have to pay income tax on the proceeds.
