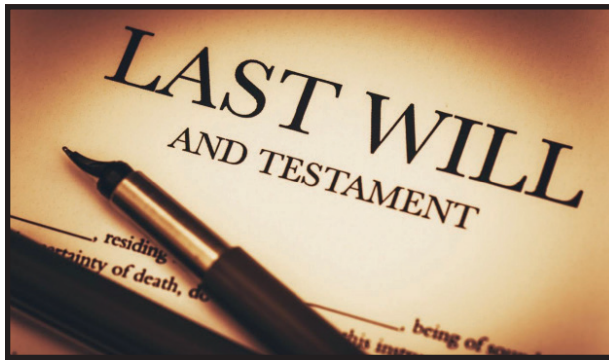

## WAYS TO GIVE TO THE LIFE CENTER OF LONG ISLAND

### Gifts of Cash

Gifts of cash are the easiest and most direct way to give to the Life Center and are tax-deductible to the extent permitted by law. The gifts can be fulfilled over a multi-year period (up to five years) following a payment schedule determined by the donor. Gifts of cash can be made on-line by credit card, wired, by sending a check, or by contacting Gloria Schreiber, CEO.



### Gifts of Securities

Marketable securities can be an attractive asset to contribute to the Life Center. The donor who gives appreciated stock will usually avoid the capital gains tax on the stock's appreciation and will receive a charitable gains tax on the stock's appreciation and will receive a charitable deduction based on the market value on the date the stock is received by the Life Center. Appreciated gifts of stock must be held more than 12 months to qualify for long-term capital gains.



### Named Endowment Gifts

By creating an endowment, donors provide a gift in perpetuity that grows over time. Endowments can provide a naming opportunity. They create a legacy while addressing vital Life Center needs such as expansion into much needed minority communities, expansion of our Post-Abortion Ministry, expansion of social media avenues to reach greater numbers of abortion vulnerable women.

### Planned Giving

By including the Life Center in their estate plans, donors may create a legacy that will ensure the Life Center's place as one of the largest, most comprehensive pregnancy care centers in the region for generations to come. Some examples of planned giving instruments include:

- Life insurance policies
- Commercial annuities
