In our nation's capital notorious late-term abortionist Cesare Santangelo continues to operate destroying new human lives daily on the cusp of birth, or even, by his own videotaped admission, after they have been born alive! Santangelo does late term abortions—and where, in a video defendants were not allowed to show in court, he stated that he lets babies die without treatment if they are born alive during an attempted abortion—a violation of the federal Born Alive Infants Protection law.

On May 14 and 15, 2024 nine courageous defenders of new human life—already in jail since September 2023—were sentenced in federal court for engaging in peaceful, prayerful civil disobedience to try to stop Santangelo's atrocities or at least bring attention to what they allege are his criminal acts. Normally, they would remain free pending sentencing, able to get their affairs in order and spend time with their families before being incarcerated. **However, for roughly nine months (September through May) they had already been incarcerated prior to sentencing was itself a scandal and an outrage.**

Their suspicions were confirmed a year-and-a-half later, when two of the pro-life women retrieved the remains of aborted babies from the Surgi-clinic's trash, including five that were clearly late-term or full-term.

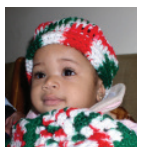
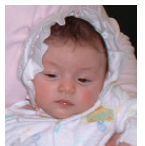
But when these women sought to turn the bodies over to authorities and have Santangelo's practice investigated, the FBI instead swooped in to re-arrest all nine participants in the pro-life sit-in 17 months earlier, upgrading local trespassing offenses to federal charges of violating the Freedom of Access to Clinic Entrances (FACE) Act, enacted during the Clinton era precisely to enable draconian sentencing for peaceful pro-life civil disobedience. In addition to **"obstruction"** under the FACE act that carries up to a year in prison; they were also charged with **"conspiracy" to obstruct**, which carries up to an additional ten years in prison, and fines of up to \$350,000.

Each day, God gave them, the strength, courage, and faith to bear the cross of this terrible injustice. In the end, *God delivered them from evil. In January 2026, President Donald J. Trump pardoned these individuals.*

Please join us at this year's Gala, as we acknowledge and thank these courageous individuals for being humble, selfless servants dedicated to God's work. We see God's love in action through their tireless efforts to protecting the most vulnerable amongst us, the preborn.

Pregnancy care centers are the No.1 threat to Planned Parenthood.
